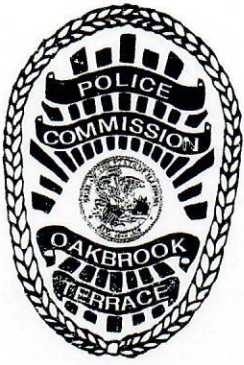
Correspondence: *National Testing Network:* The commission received copies of NTN's services and pricing.
