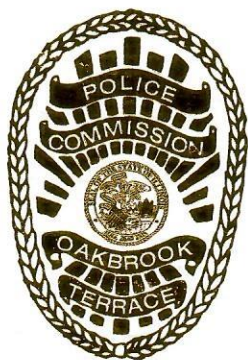
Correspondence: *DMACT Services, Inc.:* Received email regarding Lateral Entry Police Officer Oral Interview Results.
